

## PARENT / GUARDIAN CONSENT FORM

It is important that this form is completed accurately and fully to comply with the Pine Rivers Shooting Club Inc. (PRSC) safety requirements.

### Definitions

**Minor** means a person who is at least 11 years old and less than 18 years old.

**Activities** means the activities a Minor who holds a minor's license under the *Queensland Weapons Act 1990* (Qld) may participate in at a PRSC competition.

**PRSC Competition** means:

- (a) target shooting at the Madden Range, Mt Petrie Road Range or the Belmont Range using primarily pistols; and
- (b) on field shoot nights, the Minor may have the opportunity to try small calibre rifles and shotguns.

### **Consent requirements**

The purpose of this form is to ensure that any Minor who is not accompanied by their parent / guardian to perform Activities has parental consent before performing Activities.

This form **must** be completed for any Minor who is not accompanied by their parent / guardian, before the Minor can participate in Activities.

A Minor accompanied by their parent or legal guardians when performing Activities does not need to complete this consent form.

A person who is less than 11 years old is not permitted to perform any Activities regardless of whether their parent/guardian has given their consent.

### **PRSC competition details**

PRSC will take all reasonably practicable steps to ensure the following occurs at a PRSC competition:

- (a) All first time attendees to a PRSC competition will be taken through a firearms safety session by a range officer in the designated safe area.
- (b) The firearms safety session will teach the first time attendee how to safely handle a firearm.
- (c) All PRSC competition attendees will participate in a safety brief prior to commencing each competition.
- (d) The competition will be conducted under the direction of the Controlling Range Officer and assisting range officers.
- (e) Each Minor will be under the guidance and direction of a range officer who has been appointed to oversee that Minor for the night.
- (f) PRSC will provide eye and ear protection for attendees while performing Activities during competition.
- (g) Firearms can be hired from the PRSC at each competition.

Any Minor participating in a PRSC competition must comply with the following rules:

- (a) If a Minor does not have a minor's licence in accordance with the *Weapons Act 1990* (Qld) the Minor must complete the **attached** Form 33 each time before the Minor performs Activities. The Form 33 must be counter signed by the minor's parent / guardian and the minor must provide a current photo ID eg Student ID.
- (b) All attendees must wear enclosed footwear.
- (c) Loose clothing must not be worn when participating in Activities due to the safety risk loose clothing imposes.

**Competition costs**

The cost per competition is:

- (a) \$20.00 for non-members on normal competitions.
- (b) \$7.50 for PRSC Minor members on normal competitions.
- (c) An extra \$5.00 fee will be charged in addition to normal competition charges for the Ribbon Competition (2nd Tuesday of the month).
- (d) \$15.00 hire fee for a .22, includes ammunition.

Payment is by bank Transfer or Cash.

The personal information in this form will only be accessed by authorised club members and will be dealt with in accordance with the confidentiality requirements of the Information Privacy Act 2009 (Qld) and the Privacy Act 1988 (Cth).

The personal information in this form will not be disclosed to any other person or agency unless it is for the purpose stated above, the disclosure is authorised or required by law, or you have given PRSC permission for the personal information to be disclosed.

### **Competition risks and insurance**

The competition outlined above carries an inherent risk of physical injury occurring. The PRSC does not have personal accident injury insurance cover for children. If your child is injured as a result of an accident or incident while performing Activities, all costs associated with the injury, including medical costs are the responsibility of the parent / guardian.

Medicare and private health insurance may cover some medical costs. Any other medical costs not covered by medicare or private health insurance as applicable must be covered by parents / guardians.

It is the parent's / guardian's decision to determine the level of private health insurance they obtain for their child based on the high risk involved with participating in the Activities. Please consider possible medical costs and the high risks involved with participating in Activities when you are deciding whether or not to allow your child to participate in PRSC competitions.
